(57) **CLAIM**

The ornamental design for a three ball internally illuminated wand tip, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a three ball internally illuminated wand tip, the back view being the same. A wand handle is shown in hidden lines to provide positional orientation.

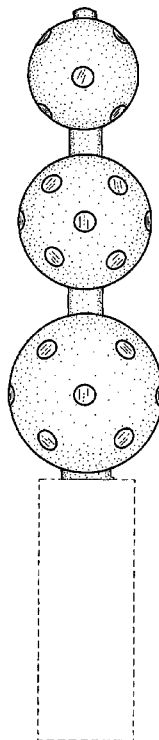
FIG. 2 is a left side view thereof, the right side view being the same;

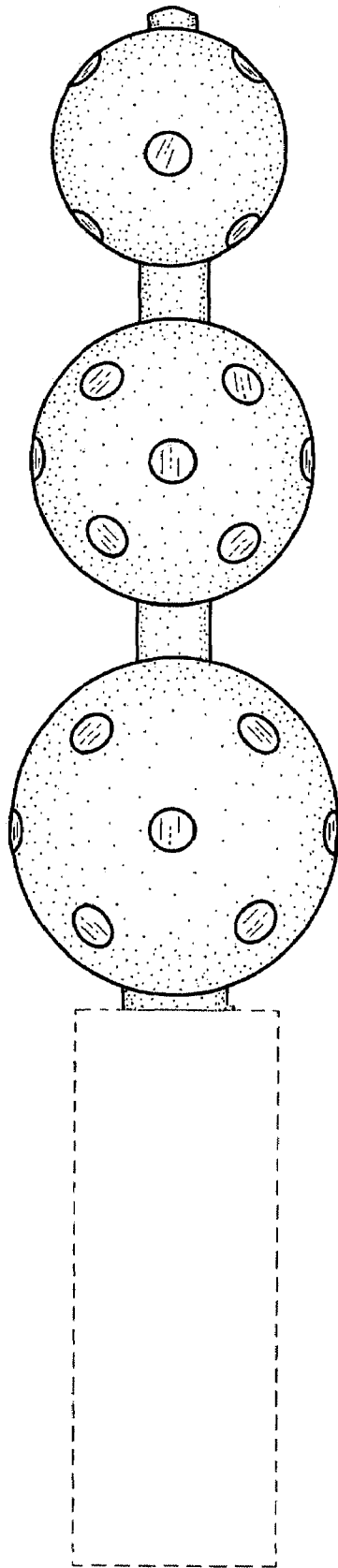

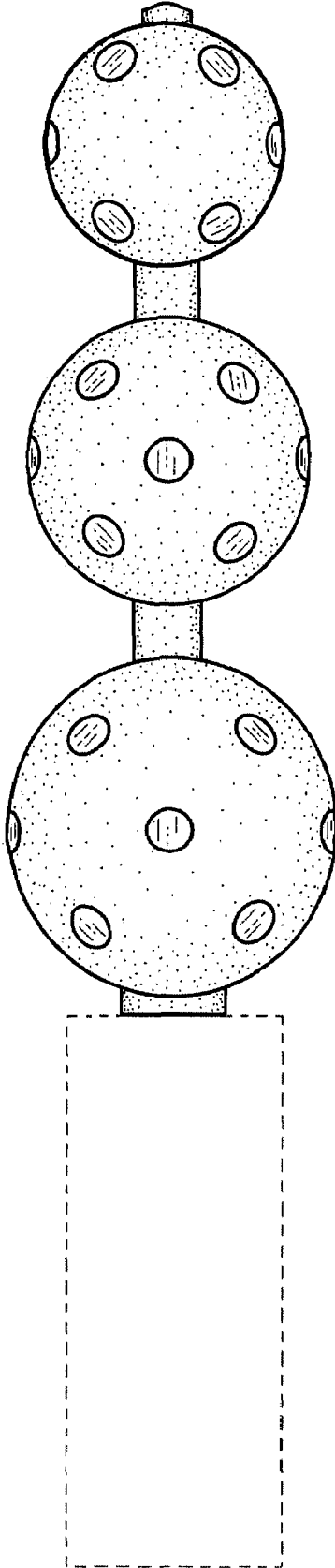

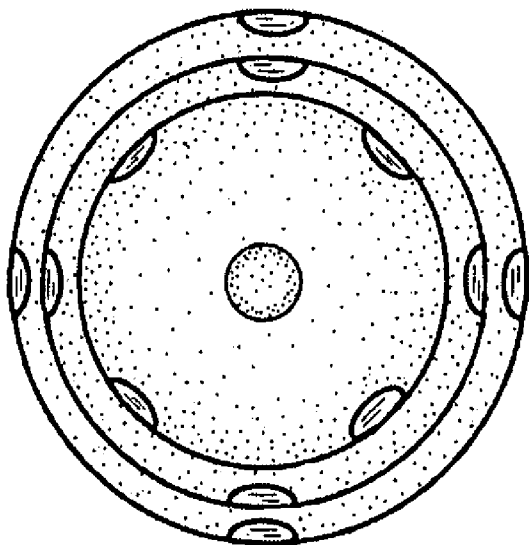

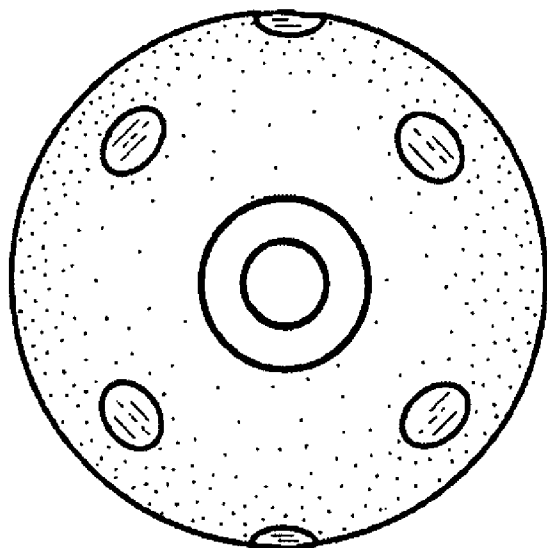
