left and right side views being the same; and,

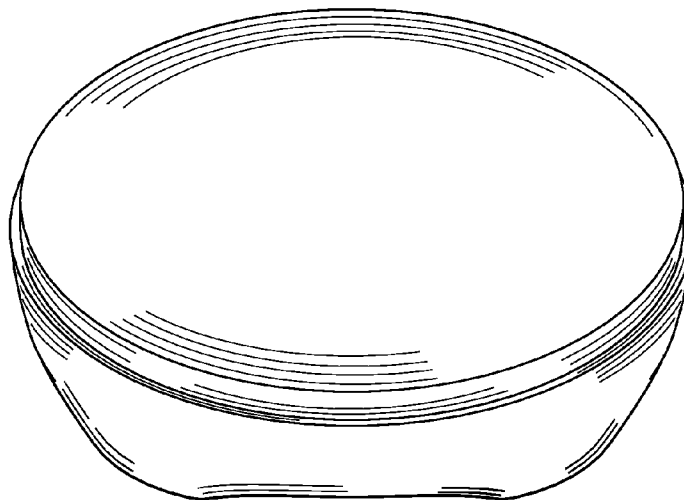
FIG. 4 is a perspective view thereof.

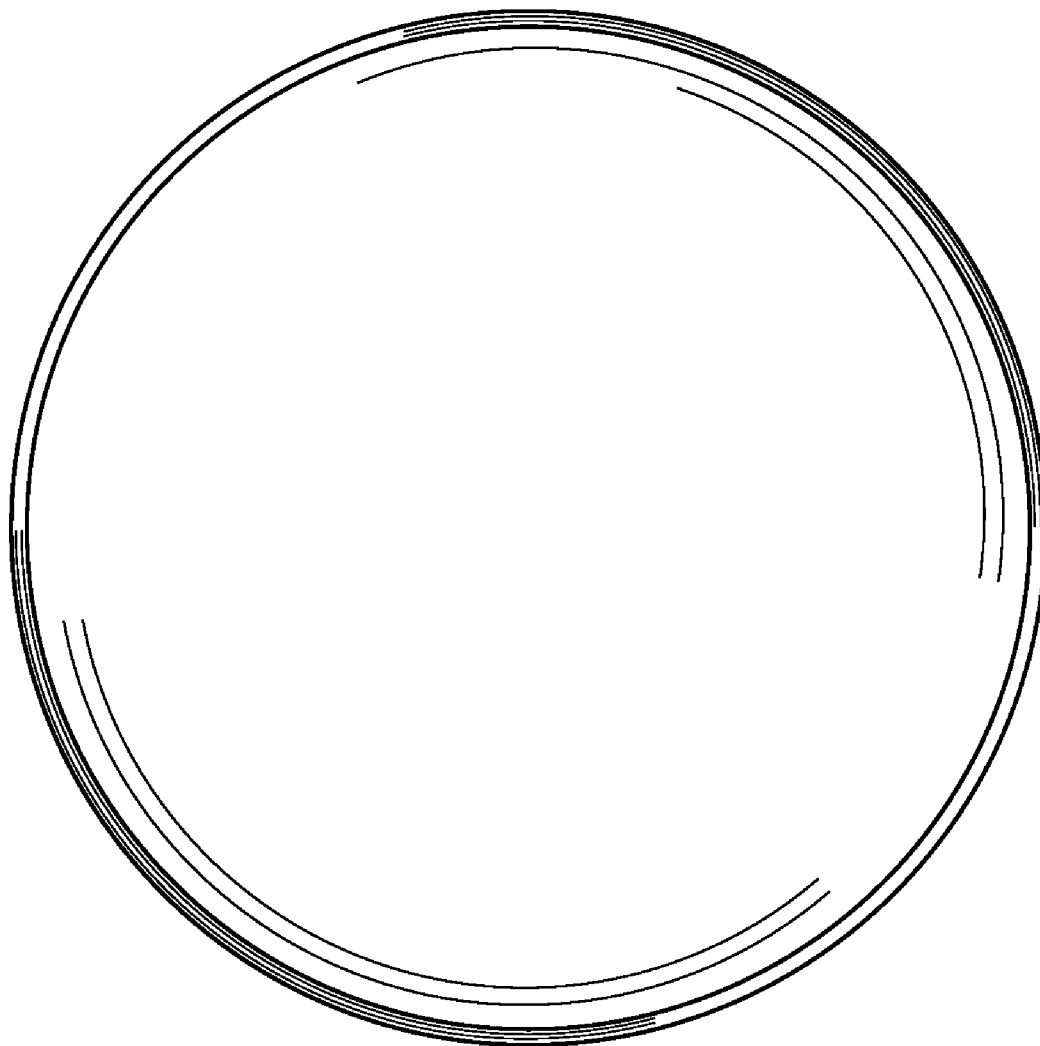

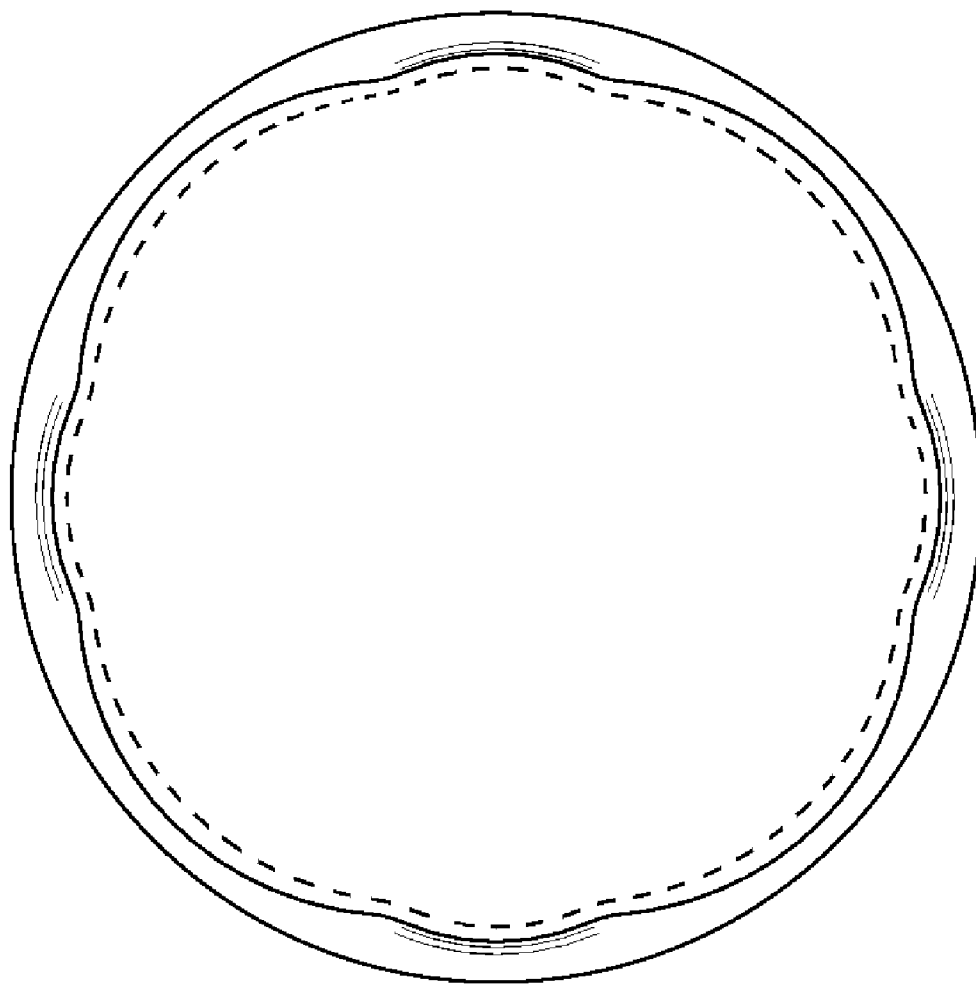

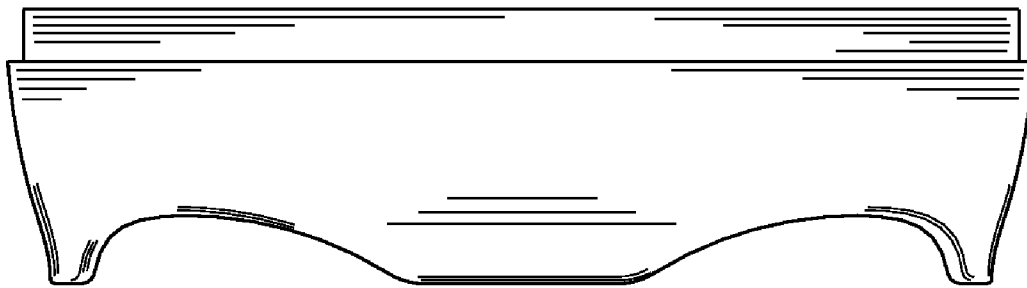

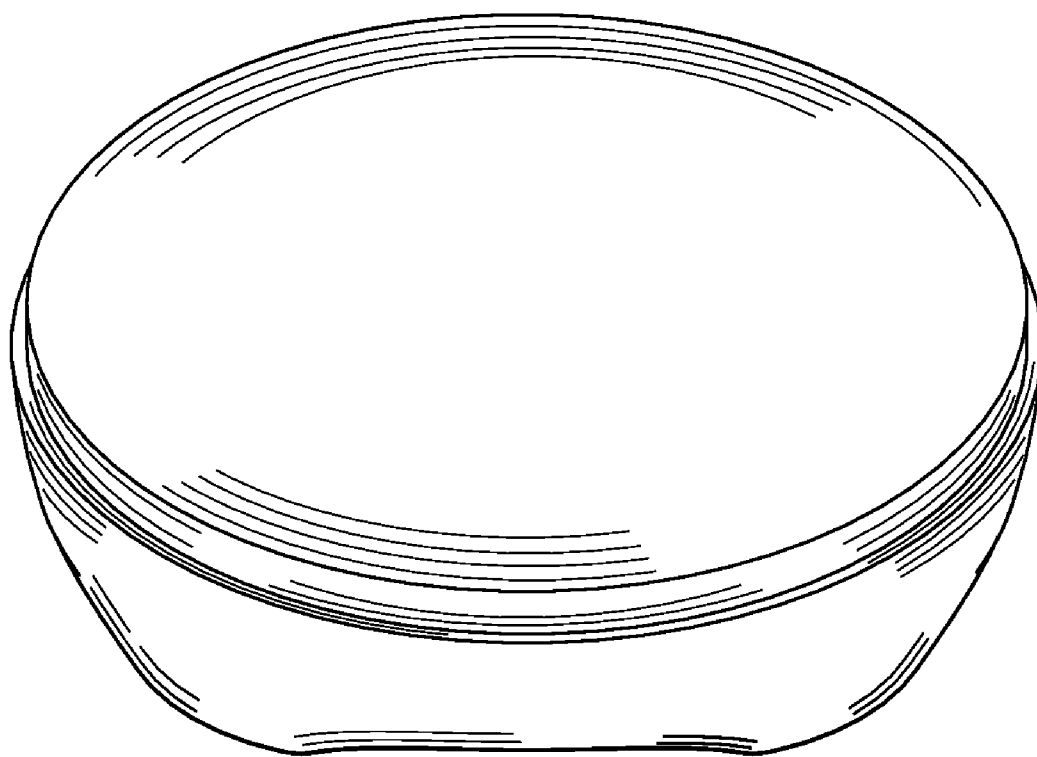
