FIG. 2 is a bottom perspective view thereof;

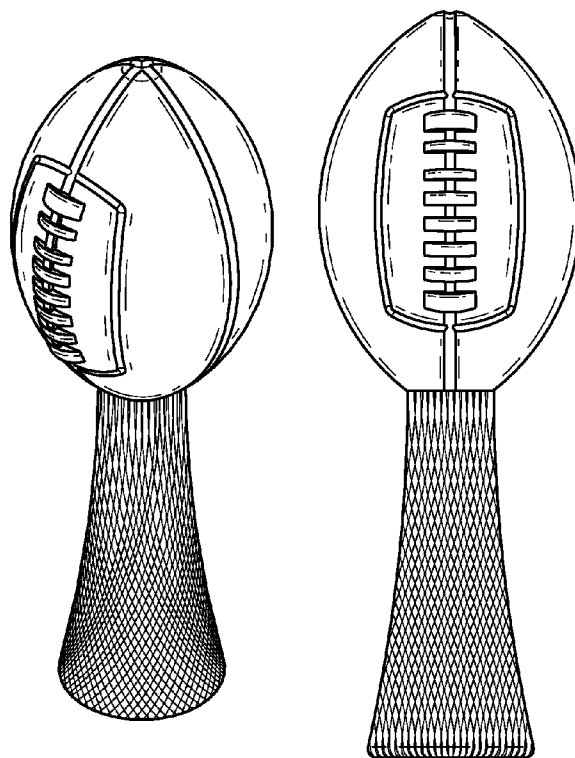
FIG. 3 is a front view thereof;

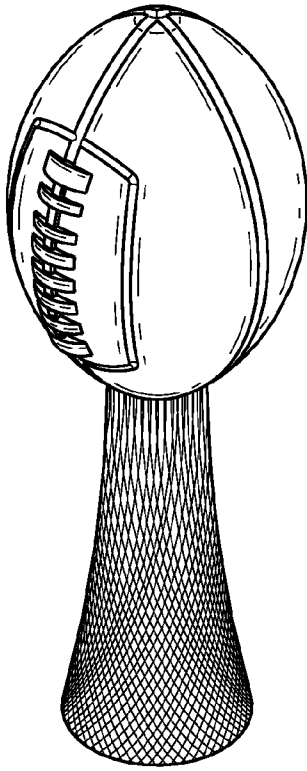

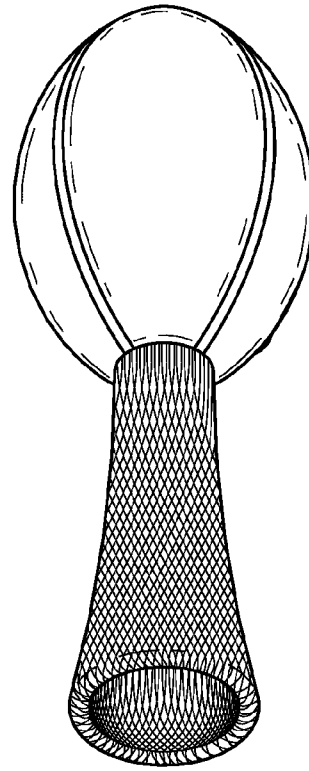

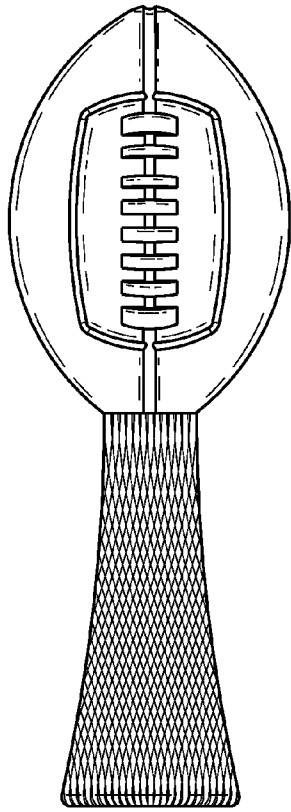

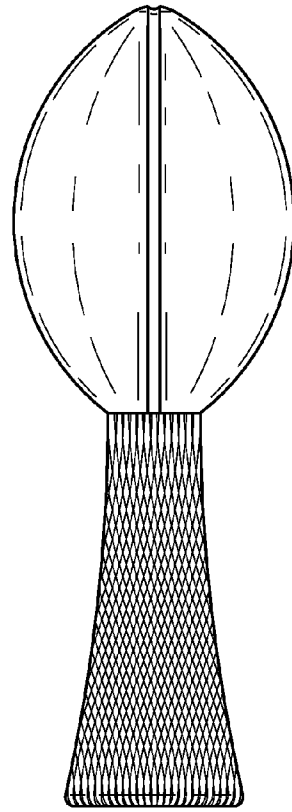

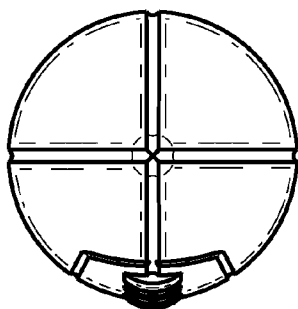

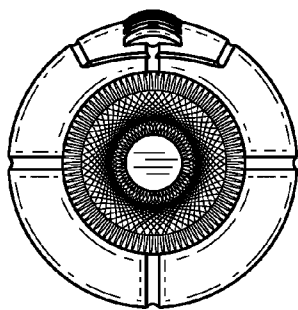
